## **DIRECTIONS**

### **275 North from Clearwater, St. Petersburg, Westshore area:**

Go North on 275 from either Howard Frankland Bridge or Courtney Campbell Causeway via Memorial Hwy. (TIA).

Take the exit- exit number 44- toward DOWNTOWN-EAST/WEST.

Take the ASHLEY ST ramp toward DOWNTOWN-WEST/TAMPA ST.

Merge onto N ASHLEY DR.

Turn SLIGHT LEFT to take the TAMPA ST ramp toward AQUARIUM-SEAPORT ARENA/CONVENTION CTR/HARBOR ISLAND.

Turn SLIGHT RIGHT onto N TAMPA ST/FL-685 S/US-41 BR S.

Stay in left hand lane.

Cross KENNEDY BLVD – Fifth Third Center is on your immediate left.

Proceed approximately 1/2 block and turn left into parking garage marked “Valet” parking.

Take parking garage elevator to 3rd floor.

Exit elevator to left, turn left at end of hall, go through glass doors, down steps and take elevator to 6th floor.

## **DIRECTIONS**

### **I-4 heading West from Orlando or I-75 to Downtown TAMPA:**

Take I-4 heading West to Tampa

Merge onto I-275 S via the exit- on the left.

Take exit number 44- toward DOWNTOWN-WEST.

Merge onto N ASHLEY DR.

Turn SLIGHT LEFT to take the TAMPA ST ramp toward AQUARIUM-SEAPORT ARENA/CONVENTION CTR/HARBOR ISLAND.

Turn SLIGHT RIGHT onto N TAMPA ST/FL-685 S/US-41 BR S.

Stay in left hand lane.

Cross KENNEDY BLVD – Fifth Third Center is on your immediate left.

Proceed approximately 1/2 block and turn into parking garage marked “Valet” parking.

Take parking garage elevator to 3rd floor.

Exit elevator to left, turn left at end of hall, go through glass doors, down steps and take elevator to 6th floor.

## **DIRECTIONS**

### **Brandon to Downtown TAMPA:**

Take CROSSTOWN EXPWY/FL – 618 W.

Take the SR-60 exit- exit number 8- toward DOWNTOWN-EAST.

Stay straight to go onto E JOHN F KENNEDY BLVD/FL-60 W/US-41 BR N. Continue to follow E JOHN F KENNEDY BLVD/FL-60 W

End at 201 E KENNEDY BLVD TAMPA FL.

Stay in left hand lane.

Turn left on to Tampa Street – Fifth Third Center is on the corner.

Proceed approximately 1/2 block and turn left into parking garage marked “Valet” parking.

Take parking garage elevator to 3rd floor.

Exit elevator to left, turn left at end of hall, go through glass doors, down steps and take elevator to 6th floor.

## **DIRECTIONS**

### **275 South from Lutz area:**

Merge onto I-275 S toward ST PETERSBURG.

Take EXIT 45A toward DOWNTOWN EAST-WEST.

Take the ASHLEY ST ramp toward DOWNTOWN-WEST/TAMPA ST.

Merge onto N ASHLEY DR.

Turn SLIGHT LEFT to take the TAMPA ST ramp toward AQUARIUM-SEAPORT ARENA/CONVENTION CTR/HARBOR ISLAND.

Turn SLIGHT RIGHT onto N TAMPA ST/FL-685 S/US-41 BR S.

Stay in left hand lane.

Cross KENNEDY BLVD – Fifth Third Center is on your immediate left.

Proceed approximately 1/2 block and turn left into parking garage marked “Valet” parking.
